NOTICE

Whereas, vide this office notification Number 01 and 02, Dated: 26-10-2022 and 02-12-2022 posts of **Work watcher, Coolie/ Mate cleaner, Class IV/Orderlies/Store khalasi/ Attendant/Chowkidar//Gardener/Nursing Orderly/Mirab/ Safaiwala/Laboratory Attendant etc** were advertised, seeking application from the eligible candidates,

Whereas, for the above mentioned posts, the eligibility criteria prescribed a Maximum qualification of 10+2 only and same was notified for the information of the concerned candidates.

Whereas, the online portal of the LAHDC-KSSRB detected that 1733 candidates with higher than the prescribed qualification had applied for the above mentioned posts.

Whereas, vide this office Notification No: KSSRB/Posts/Cancel/2023/6-23, Dated: 13.04.2023, 1733 applications were rejected of those candidates, who had applied in violation of the eligibility criteria.

Whereas, following the above mentioned rejection notification, Chairman LAHDC-KSSRB received various representations from the aggrieved candidates, alleging therein that many candidates with higher than the prescribed eligibility criteria have not been included in the rejection list.

Whereas, the Online Portal of LAHDC-KSSRB detected only those candidates who had applied for both the category of posts (Graduate Level as well as Class IV) using same **Registration ID**. Hence the claim of the aggrieved candidates cannot be ruled out as there is possibility of more such candidates left undetected.

Now through the medium of this notification it is impressed up on all those candidates who have applied for the above mentioned posts, adopting mischievous means, despite possessing higher than the prescribed qualification that they should desist from appearing in the examination to be held on 28th of May for the above mentioned category of posts or **else their act of wilfully ignoring this notification will be considered as case of forgery and unfair means and they will be proceeded accordingly as warranted under rule. Moreover, such candidates will be debarred from applying for all the Examination LAHDC-KSSRB.**
