Re-opening of window on LAHDC-KSSRB Portal for applying online for the District Cadre posts of Teacher-regarding.

## NOTICE

Whereas, Director School Education Department, UT Ladakh referred 23 No of posts of Teacher vide letter No. Estt-I/Edu-51/Distt.Cadre-posts/2022 dated.23.03.2023 to Ladakh Autonomous Hill Development Council-Kargil Services Selection Recruitment Board;

Whereas, the LAHDC-KSSRB, advertised the 23 No of posts vide advertisement Notice No. 01 of 2023 dated.27.06.2023 with 30.07.2023 as the last/crucial date for applying online on the portal, as Graduate Level Posts.

Whereas, pursuant to the said notification, <u>605</u> online applications were received on the portal up-to the last date i.e <u>30.07.2023</u>.

Whereas, a corrigendum notice was issued vide No. KSSRB/Adv-2023/222-29 dated. 04.07.2023 to intimate the candidates about the relaxation of 5% qualifying marks in CTET Paper I & II, as per S.O 39 dated. 16.06.2023 of Education Department, UT Ladakh.

Whereas, a notice was issued vide No. KSSRB/Correction/2023/385-90 dated. 18.09.2023, to provide an opportunity to the applicants to Edit/Correct the particulars, if required, in their online application forms.

Whereas, the School Education Department, UT Ladakh vide S.O 89 dated. 30.10.2023 issued under No. A/347/2023-Estt/SED/576-85 dated. 30.10.2023 further relaxed the qualifying criteria for CTET conducted by the CBSE for Paper I & II for the candidates belonging to the reserved categories such as ST/SC/OBC/PH, up-to 10% of the qualifying marks.

Whereas, suitable instructions were sought from the competent authority on whether the relaxation criteria notified vide the above referred S.O 89 dated. 30.10.2023 of the Department of Education, UT Ladakh is to be implemented or otherwise for the 23 posts of Teacher already advertised vide notification No. 01 of 2023 dated. 27.06.2023.

Whereas, in response to the same, the competent authority has approved the provision to invite applications from eligible candidates under the new relaxed norms, however restricting the eligibility to the crucial date i.e., last date of submission of online forms which was notified as 30.07.2023. It has also been intimated that the application portal may be re-opened for a specific time frame for such candidates to apply online for the said posts.

Therefore, in view of the above, it is notified for information of the eligible candidates that pursuant to the relaxation of 10% marks for the CTET Paper I and II to the candidates belonging to the reserved categories ST/SC/OBC/PH, notified vide S.O 89 dated: 30.10.2023, and subsequent approval by the competent authority, the window for applying online on the LAHDC-KSSRB Portal for the posts of Teacher shall be re-opened for a period of 07 (Seven) days as per below given details:

Candidates possessing the requisite eligibility under the relaxed norms up to the crucial/last date i.e <u>30.07.2023</u> of the advertisement Notification No: 01 of 2023 dated. 27.06.2023 only shall apply for these posts latest by 9th December, 2023 up to 06.00 PM after which no application shall be entertained under any circumstances. Candidates who have already applied against the above advertisement need not apply again. Further, LAHDC-KSSRB shall not undertake any detailed scrutiny of applications for the eligibility at this point of time and therefore, candidature of the applicants will be accepted only provisionally.

All other terms and conditions shall remain the same as mentioned in the advertisement notice no and date mentioned above.
