**Subject: Provisional selection list for appointment against 9 (nine) posts of Driver Grade-II (UR- 08, ST-01).**

## **NOTICE**

Whereas, vide this office notification No. KSSRB/Prov-Select-List/2023/546-65 dated. 30.10.2023, provisional selection list for 9 (nine) posts of Driver Grade – II was issued along with other posts.

Whereas, representation(s) were received from some candidates regarding verification of TRANS documents of the provisionally selected/waiting list candidates for the Posts of Driver Grade – II and accordingly clarification was sought from the concerned department. Besides, notice was also issued vide No: KSSRB/Prov-Select-List/DV/2023/621-626 dated. 14.11.2023 informing the candidates to submit the TRANS documents to this office with clear mention of TRANS issuance date.

Whereas, in response, the concerned department forwarded the same mentioning TRANS issuance date against each candidate and a board was constituted to examine/scrutinize the said documents and determine/decide the eligibility of each candidate.

Whereas, the board in its report submitted that two candidates falling at S. Nos. 1 and 2 of the provisional select list and S. Nos 1 and 2 of the general waiting list issued under Item No.7 of the Notice No: KSSRB/Pro-Select-List/2023/546-65 dated: 30.10.2023 are not eligible for the said posts as per the contents of the advertisement notice/recruitment rules of the indenting departments.

Whereas, based on the report of the committee, the provisional selection of the four candidates were cancelled vide notification No. KSSRB/Notice/2023/956-63 dated.27.01.2024 and document verification of fresh candidates was conducted on 03.02.2024.

Therefore, in view of the above, the provisional selection list for the post of Driver Grade – II is annexed as **ANNEXURE "I"** and based on the preferences received from the candidates, their merit in the list and vacancy of the posts as per requisition of the indenting departments, the provisionally selected candidates are also allocated the respective departments mentioned against each.

While due care has been taken to compile the list, LAHDC-KSSRB reserves the right to correct/modify/change it at any stage, if required. Moreover, the list is purely provisional and subject to scrutiny and verification of eligibility, essential qualification, category, etc. by the appointing authority.

Further, the provisional selection list is subject to the outcome of any writ petition in any competent Court of Law/Tribunal, etc.
