Cancellation of provisional selection and department allocation of Work Supervisor-I posts-regarding.

ORDER

Whereas, as per requisitions received from the indenting departments, the LAHDC-KSSRB had advertised 09 posts (4-UR, 5-ST) vide Advertisement Notice No. 02 of 2022 dated 02.12.2022 as clubbed vacancies/posts for recruitment as Work Supervisor-I in the departments of Public Works (R&B) and PHE/I&FC, Kargil;

Whereas, a common written examination was conducted for these posts requiring matric (10th pass) as minimum qualification on 28th May, 2023;

Whereas, based on the merit secured in the written examination, **27 candidates** were provisionally shortlisted for Document Verification which was conducted through a Board constituted vide order No. KSSRB/DV-Boards/2023/289-95 dated. 20.07.2023. Out of 27 provisionally shortlisted candidates, **23 candidates** appeared for Document Verification;

Whereas, a Technical Committee was constituted vide order No. KSSRB/ DV-Boards/ Posts/ 2023/705-709 dated. 05.12.2023 to ascertain the eligibility or otherwise of the candidates based on the Technical/Experience certificates submitted by them during the Document Verification for these posts in terms of recruitment rules notified by the concerned Indenting Departments as mentioned in the advertisement notice;

Whereas, **10 candidates** were declared eligible for the selection to the posts of Works Supervisor-I by the Technical Committee;

Whereas, based on their merit of OMR based written examination and as per the report of the Technical Committee, candidates were provisionally selected for the 09 posts (UR-04, ST-05) as per the category-wise break-up received from the departments and selection notice for the post of Work Supervisor-I of PHE I&FC and Public Works (R&B) Departments was issued vide No. KSSRB /Pro-Select-List/2023/1147-61 dated 15.02.2024;

Whereas, the candidates were asked to submit their preferences for these departments vide notice No. KSSRB/Notice/2023/1399-1407 dated. 15.03.2024 as per format which was annexed with the notice.

Whereas, based on the preference received from the candidates, their merit in the list and vacancies of the posts as per requisition of the indenting departments, the provisionally selected candidates were allocated departments and notified the same vide No. KSSRB/Prov-Select-List/DA/2023/1421-1434 dated. 20.03.2024 and the Head of the respective

Departments were also intimated to initiate appointment process. However, in compliance to the directions of the Hon'ble CAT Bench Srinagar issued in the matter of O.A 122/2024, the provisional selection in respect of 2 candidates figuring at S. No 8 & 9 of the list notified vide No. KSSRB /Pro-Select-List/2023/1147-61 dated 15.02.2024 was withheld and accordingly the request for their department allocation was not submitted to the concerned authorities.

Whereas, vide Public Works (R&B) Department, UT, Ladakh letter issued under file No. A-12021/1/2022-PWD(R&B)/718-22 dated. 01.04.2024, it has been intimated/clarified that most of the selected candidates are having certificates in "Work Supervisor" that have not been awarded either by NCVT or by SCVT, as prescribed in recruitment rules. It was further instructed to convey the revised selection list for the process of appointment strictly as per the qualification prescribed in the recruitment rules.

Whereas, the Technical Committee in light of the above letter, re-examined the certificates of the selected candidates and the said committee submitted its report vide No. DDE-K/Technical-Committee/Report/14-15 dated. 03.04.2024 thereby declaring only 1 candidate namely Syed Hussain, bearing Application No. KSSRB22019905 & Roll No. 312354 is eligible for the said post out of the total 10 candidates; 09 earlier provisionally selected candidates and 1 waiting list candidate.

In view of the above, the provisional selection and department allocation issued vide No. KSSRB /Pro-Select-List/2023/1147-61 dated 15.02.2024 & No. KSSRB/Prov-Select-List/DA/2023/1421-1434 dated. 20.03.2024 are cancelled ab initio. However, the provisional selection and department preference for the above mentioned eligible candidate namely Syed Hussain, bearing Application No. KSSRB22019905 & Roll No. 312354 shall remain valid.

Further, the revised provisional select list of the candidates shall be issued in due course of time after conducting the fresh document verification for selecting the eligible candidates for these posts.

This issues with the prior approval of the Chairman, LAHDC-KSSRB.
